Wildflower Garden Update

The Parish Council agreed proposals for a wildflower garden after an open forum discussion in September. See village website for full info. Grass and a small layer of soil was removed by a contractor and volunteers helped sow seeds and plant bulbs in October. There are already signs of the seeds sprouting. To tackle some of the damper areas, flag iris and other water tolerant wildflowers may be planted next year. Spacehive will transfer the money pledged once the lease between CW&C and GSPC has been agreed. The trees have been surveyed in advance of the lease being considered and CW&C will remove one Robinia nearest Fox Cover as there are signs of decay. Next year herb planters will be installed and as the grass and flowers grow paths will be mown. Thanks to all those who have helped so far. Parish Forum discussion - The Parish Council has introduced Open Forums 30 minutes before some meetings to encourage two-way discussion between residents and councilllors. In September the Wildflower Garden was discussed and in November, the Parish Precept. 15 minutes Public Speaking Time is still available at Parish Council meetings when local issues can be raised. It is not always possible to answer questions raised at PST and when appropriate the issues are scheduled for discussion by members at a future meeting, or a response may be given at the following meeting.

Budget - possible options - Which do you support?

• Review grounds maintenance including frequency of CW&C cutting back weeds on footpaths.

• More seating around the parish, possibly near village hall and shops.

- Lengthsman Advertise to fill vacancy, increase hours
- More play equipment

• Station Lane pedestrian improvements – preliminary discussions with Mickle Trafford and some landowners already started.

- Fitness trail equipment for all ages
- Something for teenagers to do E.g. table tennis table
- Support for local bus services or alternatives
- Coronation event 6th May 2023

Let the Clerk know by 6th December if you have other suggestions or what you think of these and popular ideas will be investigated and costed. The Parish Precept raised £23,800 last year and at £35.43 per Band D property was less than £3 a month per household. Adding £1,000 to the total precept for new items would increase Council Tax by a little under £1.50 per year. There are also Reserves, some earmarked for Contingencies, and some for the long-held desire to purchase more land in the village for recreational use. If anyone owns or knows of suitable land, please let the clerk know. A request to smokers Please dispose of your cigarette ends carefully, not on the pavement or carpark. They're hard for volunteer litter pickers to pick up.

Overhanging branches Now is the time to cut back your hedges and shrubs especially if they obstruct passers-by. Some pedestrians are forced off the pavement to get past which is dangerous for those with buggies, wheelchairs, or walking aids.

Planning. The Parish Council is consulted on planning applications by the Planning Authority - Cheshire West & Chester Council. The Parish Council does not grant or refuse planning permission but can express support or objection. Parish councillors usually visit sites of applications before making comments. Occasionally residents have been concerned about developments or activities nearby which do not appear to have planning permission. In such cases contact should be made with CW&C, email planning@cheshirewestandchester.gov.uk Where planning applications have been submitted any residents wishing to comment can do so online via CW&C website.www.cheshirewestandchester.gov.uk/planning

Tile Farm New enforcement action has been started by CW&C against Tile Farm and there is a new planning application 22/03552/LDC for a Certificate of Lawfulness relating to mixed-use including haulage operations, motocross, quad bikes and clay pigeon shooting. Closing date for comments - 9th November. Comments submitted previously need to be resubmitted.

Land on Belle Vue Lane Several residents were at November PC meeting to raise concerns about activities on Greenbelt at land on Belle Vue Lane, including increase in heavy vehicles, import of materials, bonfires and the nature of the site which appears to them to be industrial rather than agricultural. At the start of the meeting, Mr Barker, who is connected with the site, invited residents to visit him on site to discuss any problems He also said that the intention was to establish a small holding with a dwelling which in his view would protect the village from other development and he has licences for importing materials.

members serve on committees (Eg. Finance, Communications), and carry out various tasks such as monthly street surgeries, site visits for

planning applications, and liaising on public transport and traffic issues. They also help with the village fete, Remembrance Day preparations

and service, write and deliver newsletters and take care of planters. Several members are involved in other organisations and groups within the

parish including including serving as a school governor, or committee members with Greenspace, Village Green, Wildflower Garden and

Community Association. Training is provided for parish council duties and there are regular meetings, currently via Zoom, with the Cheshire

Association of Local Councils where Jackie Weaver is CEO and with CW&C, Details of meetings are available on the parish and village

websites. Anyone interested could perhaps think about attending a parish council meeting if they haven't already done so, to see how it works

and take a look at minutes of previous meetings to familiarise themselves with the topics discussed and decisions taken.
